JOINT MOTION OF PLAINTIFF AND DEFENDANT
TO EXTEND PRETRIAL ORDER

The Plaintiff, Jin Li, and Defendant, Brown University in Providence in the State of Rhode Island and Providence Plantations, hereby move to extend the deadlines set forth in the Court's Pretrial Order as follows:

1. All factual discovery shall be closed by June 15, 2012. (All fact discovery will be completed by this date, except by agreement or leave of Court.)

2. Dispositive motions shall be filed by June 29, 2012.

Pretrial Memoranda shall be filed with the clerk 30 days after a decision on any dispositive motions or, if no dispositive motions are filed, on June 29, 2012.

4. As reasons therefore, the parties state that they continue to negotiate a settlement of the claims. Due to the efforts made negotiating a settlement, only minimal discovery has been propounded so far. As such, if the parties are unable to settle, then the parties will need time to complete formal discovery.

Wherefore, the parties request that this Honorable Court extend the deadlines contained in the Court's Pretrial Order as set forth above.
